- 1. A booking fee of \$200.00, payable to Kinda Silly Farm LLC., is due with a signed contract. A collection fee of \$400.00 will be charged per collection of the stallion. The balance of the stud fee, \$1000.00 will be due once the mare in confirmed in foal. Owner is required to pay any and all shipping fees.
 - * Semen will NOT be shipped before the \$200.00 booking fee is paid in full.

* If mares are being bred on farm an insemination fee of \$75.00 will be charged per insemination. Mare board per month for a single mare is \$800.00 (\$26/day) stall board and \$500.00 (\$17/day) field board. Board per month for a mare and foal is \$1050.00 (\$35/day) stall board and \$800.00 (\$26/day) field board

- A copy of the mares registration papers, with current owner listed or lease agreement MUST accompany this contract. The owner recorded on the registration papers will be recorded on the stallion breeding report.
- 3. A request for shipment of cooled transported semen must be made at least 24 hours prior to shipping time. Cancellation must be made by 8:00am shipping day.
- 4. It is understood that, should a live foal NOT result from the breeding, the mare owner will be entitled to rebreed the Mare the following season, provided the Kinda Silly Farm is given a proper written notification from a licenses veterinarian that the Mare has aborted, absorbed or produced a non-viable foal within one week of such event. Rebreed will be given with no additional stud fee, however a collection fee of \$500.00 per collection and shipping fees will be the responsibility of Mare owner.
- 5. In the event that the stallion dies or becomes unfit for service or in the event that the Mare dies during the breeding season the Mare owner may substitute another mare or breed the Mare to another stallion at the Kinda Silly Farm.
- 6. Kinda Silly Farm agrees to execute all necessary documents of the registration of the offspring of the breeding; provided, however, that said breeders certificate will not be issued until all fees and expenses incurred hereunder have been paid in full.

7.	Mare owner certifies that Kinda Silly Farm is obligated to transport cooled semen of the address of record which Mare owner has provided prior to any shipment. All shipments will be shipped to the address provided above, unless otherwise communicated in writing and confirmed by Kinda Silly Farm staff.	nly to
8.	Mare owner certifies that only the mare who is the subject of this breeding contract be inseminated by the shipped cooled semen. If semen is used on a Mare not state this contract, Mare owner shall owe additional breeding fees to Kinda Silly Farm.	
9.	If more than one embryo results from a breeding during embryo harvesting, Mare of must pay an additional stud fee within sixty days of confirmed pregnancy to receive certificate for the additional foal(s).	
10.	This contract, when signed by the Mare owner and a Kinda Silly Farm agent and accompanied by payment of the stud fee and expenses, shall be a binding contract both parties on the above terms and conditions. This contract constitutes the entire agreement between the parties concerning the breeding of the Mare and Stallion.
